**EVIDENCE OF CONSPIRACY, FRAUD, AND PERJURY
BY J.K. ROWLING, SCHOLASTIC INC., TIME-WARNER
ENTERTAINMENT, AND THEIR COUNSEL WILL BE ADDRESSED
BY THE COURT**

New York, NY, January 29, 2007, 10:00 AM: The United States Court of Appeals for the Second Circuit has scheduled Oral Arguments to be heard in Case No. 05-6976-cv following their review of the appeal and brief submitted by Nancy Kathleen Stouffer, Defendant/Appellant. The brief and its exhibits provided the Court with indisputable proof that J.K. Rowling, Scholastic Inc., Time-Warner Entertainment, their counsel, and others were part of a conspiracy. The charges made include fraud and perjury by Officer's of the Court as part of a scheme to skew the Court's prior opinions. The shocking details outline a strategic plan implemented to divert the Court's focus and deny Mrs. Stouffer's Constitutional right to due process.

Nancy is asking the Court to address the seriousness of the charges made, set aside the Summary Judgment and Sanctions, and grant every relief available within their discretion as provided by Rule 60, or otherwise, including, but not limited to the sanctioning of the Plaintiff's and their counsel. The conduct of the Plaintiff's/Appellee's and Officer's of the Court had a direct impact on the Court's and their ability to function with impartiality.

Although the conspiracy, fraud, and perjury have caused Mrs. Stouffer to suffer extreme emotional and financial hardships, the loss of her properties, death threats, and attempts made on her life, these issues remain legally nothing more than a side effect of the briefed corruption. The real question for the Court is whether or not it will condone such egregious misconduct by its own Officer's, and allow such misconduct to serve as a foundation for any judgment? Nancy firmly believes the corrosive actions of the Plaintiff's/Appellee's rise to the level of racketeering, and is asking the Court to redress them accordingly.

Mrs. Stouffer is reaching out to news organizations and outlets not controlled by the media giants named in the actions to give her a public voice. A voice that has been unjustly silenced by lies, innuendo and misperceptions created by the Plaintiff's/Appellee's, while her life was being jeopardized and her character maligned.
